



## **Gone to the Dogs Daycare Agreement**

This agreement between \_\_\_\_\_ (PET OWNER or guardian) AND Gone to the Dogs, Inc. (called Gone to the Dogs here forward) with the express purpose of providing a service of canine daycare and agreed upon services. This agreement applies to all dogs (present and future) and all visits.

### Gone to the Dogs WILL PROVIDE:

Daycare play, exercise, downtime in a secure environment with dogs being separated by size. Ala Carte services of dog walks and/or trail walks may also be provided at the owner's discretion.

### OWNER WILL:

Present their dog flea and parasite free, proof of spay/neuter, up to date Rabies, Distemper, Parvo (or Titer test), and annual Bordetella vaccinations with Veterinary clinic documentation provided. **Proof of vaccination coverage must be up to date prior to entering Daycare.**

All dogs entering Gone to the Dogs Daycare for the initial time must first be given a short interview/assessment to check for temperament/socialization, as well as fleas.

As a condition for using our Dog Daycare services for your pet, the following Waiver & Assumption to Hold Harmless must be signed:

By choosing to utilize the Dog Daycare services at Gone to the Dogs, I agree to the following:

I agree to pay the rates that are in effect at the time my pet is at Gone to the Dogs. I am aware that extra charges may be incurred for such things as grooming, training, adventure hikes, etc, and I agree to pay them at the time of pick up.

I understand that this is a cage-free facility and if my dog participates in interactive (i.e. not caged) daycare and/or activities there is some risk of injury and illness. Despite all dogs being screened for temperament and health, dogs are not always predictable and the unexpected may occur. I recognize that the benefits of an interactive playgroup are valuable to my dog, and I accept the potential risks. I further agree to pay veterinary and medical expenses incurred as a result of injury or illness caused by my dog. I also agree to pay any veterinary and medical expenses incurred by my dog as a result of injury or illness.

If my pet appears to be ill or injured, and if I am not reachable, I authorize Gone to the Dogs to engage the services of a veterinarian at my expense, to give other requisite attention, and to make whatever decisions are required for my pet's veterinary treatment. I will not hold Gone to the Dogs liable for failure to seek veterinary attention or for decisions made under this contract.

I understand that Gone to the Dogs will exercise due diligence and care in the guardianship of my pet. I hereby waive and release Gone to the Dogs and its employees and agents from any and all liability of any nature, for injury or damage, including that which may result from the action of any dog including my own. I expressly assume the risk of such damage or injury while my dog participates in or attends any function of Gone to the Dogs Daycare while on the grounds or in surrounding areas (neighborhood walks, park adventures), or in a Gone to the Dogs employee vehicle (for Pack Walk situations or veterinary care).

On behalf of myself and all other owners of this pet, I have read and agree to the terms of this contract. I warrant that I have the authority to represent any and all other owners of this pet in signing this contract. This is a permanent agreement that applies to all pets (present and future) and all stays at Gone to the Dogs Daycare.
